PSUs in the amounts of 5,427 (vested 3/26/14); 5,427 (vested 3/26/15); and 5,425 (vested 3/26/16).

2. Includes 39,711 Restricted Stock Units (RSUs) and 2,780 Deferred Stock Units (DSUs). Each RSU represents a contingent right to receive one share of Cohu, Inc. Common Stock upon vesting (assuming continued service to the Board). Each DSU is equal to one share Cohu, Inc. Common Stock and will be settled through the issuance of common stock (i) upon the reporting person's termination of service as a director or (ii) at certain specified future dates.
